# Winslow Township School District AP Government Unit 2: Political Beliefs and Behaviors

**Overview:** The purpose of this full-year course is to give students an analytical perspective on government and politics in the United States. Students become familiar with various institutions, groups, beliefs, and ideas that constitute U.S. politics. They also become acquainted with a variety of theoretical perspectives and explanations for various behaviors and outcomes. The major goal is to ascertain the factors and influences that have an impact upon the processes that drive the operations of government. Several themes highlight the course of study: constitutional underpinnings of the United States government, political beliefs and behaviors, development of public policy, civil rights and civil liberties, and the power of political parties, interest groups and mass media.

#### **Modifications for Special Education/504**

*Students with special needs:* Supports, Accommodations, and Modifications must be provided as stated in IEP, 504 Plan, or CST Team Intervention Plan, and may include (but are not limited to) the following:

Presentation accommodations: I Listen to audio recordings instead of reading text I Learn content from audiobooks, movies, videos and digital media instead of reading print versions I Use alternate texts at lower readability level I Work with fewer items per page or line and/or materials in a larger print size I Use magnification device, screen reader, or Braille / Nemeth Code I Use audio amplification device (e.g., hearing aid(s), auditory trainer, sound-field system (which may require teacher use of microphone) Be given a written list of instructions I Record a lesson, instead of taking notes I Have another student share class notes with him Be given an outline of a lesson Be given a copy of teacher's lecture notes Be given a study guide to assist in preparing for assessments I Use visual presentations of verbal material, such as word webs and visual organizers I Use manipulatives to teach or demonstrate concepts I Have curriculum materials translated into native language

**<u>Response accommodations</u>**: <sup>[2]</sup> Use sign language, a communication device, Braille, other technology, or native language other than English <sup>[2]</sup> Dictate answers to a scribe <sup>[2]</sup> Capture responses on an audio recorder <sup>[2]</sup> Use a spelling dictionary or electronic spell-checker <sup>[2]</sup> Use a word processor to type notes or give responses in class <sup>[2]</sup> Respond directly in the test booklet rather than on an answer sheet.

Setting accommodations: Work or take a test in a different setting, such as a quiet room with few distractions S it where he learns best (for example, near the teacher, away from distractions) Use special lighting or acoustics Take a test in small group setting Use sensory tools such as an exercise band that can be looped around a chair's legs (so fidgety kids can kick it and quietly get their energy out) Use noise buffers such as headphones, earphones, or earplugs

**<u>Timing accommodations</u>** I Take more time to complete a task or a test I Have extra time to process oral information and directions I Take frequent breaks, such as after completing a task

Scheduling accommodations: 2 Take more time to complete a project 2 Take a test in several timed sessions or over several days 2 Take sections of a test in a different order 2 Take a test at a specific time of day

**Organization skills accommodations:** <sup>[2]</sup> Use an alarm to help with time management <sup>[2]</sup> Mark texts with a highlighter <sup>[2]</sup> Have help coordinating assignments in a book or planner

### Modifications for At-Risk Students

Formative and summative data will be used to monitor student success. At first signs of failure, student work will be reviewed to determine support. This may include parent consultation, basic skills review and differentiation strategies. With considerations to UDL, time may be a factor in overcoming developmental considerations. More time will be made available with a certified instructor to aid students in reaching the standards.
