**BE IT FURTHER RESOLVED** that the Board hereby declares that its discussion of the aforementioned subject(s) will be made public at a time when the need for confidentiality no longer exists, or the public's interest in disclosure is greater than any privacy or governmental interest being protected from disclosure.

**BE IT FURTHER RESOLVED** that the Board Secretary/Board Solicitor, shall read aloud enough of this resolution so that members of the public in attendance can understand, as precisely as possible, the nature of the matters that will privately discussed.

**BE IT FURTHER RESOLVED** that the Board Secretary, on the next business day following this meeting, shall furnish a copy of this resolution to any member of the public who requests one at the fees allowed by N.J.S.A. 47:1A-1 et seq.

#### RESOLUTION OF THE WINSLOW TOWNSHIP BOARD OF EDUCATION TO REOPEN CONTRACT NEGOTIATIONS WITH THE SUPERINTENDENT

**WHEREAS**, the Employment Contract Between the Winslow Township Board of Education and Dr. H. Major Poteat, Superintendent of Schools, a five (5) year contract beginning on July 1, 2017, is set to expire on June 30, 2022; and

**WHEREAS**, <u>N.J.S.A</u>. 18A:17-20.1 provides that at the conclusion of the term of a Superintendent's contract, the Superintendent shall be deemed automatically re-appointed for another contracted term of the same duration and under the same terms, as the previous contract unless the board notifies the superintendent in writing otherwise, provided that such notification shall be given prior to the expiration of the first or any subsequent contract by a length of time equal to 30 days for each year in the term of the current contract; and

**WHEREAS**, the Employment Contract similarly provides an automatic renewal provision in Article 9, Section D; and

**WHEREAS**, the Board of Education wishes to reopen contract negotiations with the Superintendent on a new contract, rather than exercise the automatic renewal clause in the Employment Contract and as provided by law.

**NOW, THEREFORE, BE IT RESOLVED**, that the Winslow Township Board of Education hereby authorize the Board Solicitor and Board President to renegotiate a new Employment Contract with the Superintendent; and

**BE IT FURTHER RESOLVED**, that the Winslow Township Board of Education hereby authorizes the Board Solicitor to provide all necessary legal notices and take and necessary actions in accordance with Article 9, Section D of the contract and <u>N.J.S.A</u>. 18A:17-20.1.
