Dr. Poteat addressed the following informational items:

- The next Real Talk with the Superintendent is Monday, January 9, 2023 at 6:30 p.m. Additional information will be provided to the community.

Wanda Glaud

Ms. Glaud read through the community bulletin board and saw disturbing news regarding a three-year-old at School #4 who was allegedly being abused by a school teacher. She asked if the teacher was on administrative leave until the investigation is complete, and if not, why. Dr. Poteat responded that the investigation was completed by the Institutional Abuse Investigation Unit and the allegations were unfounded.

Eileen Smith

Ms. Smith is the grandmother of the three-year-old child from School #4. She stated that just because the allegations were found to be untrue does not mean that the situation didn't happen. She is appalled that the teacher who harmed her grandson is back in the classroom and the teacher who was teaching for 35 years was removed from the classroom. She wants to know why. Mr. Long responded that it would be inappropriate for the Board to discuss personnel matters in a public forum. Ms. Pitts stated that the Board would be more than happy to meet with her, her daughter, and anyone else she would like to bring along to answer her questions in the Executive Session. Dr. Poteat stated that once the incident(s) are under investigation, the Superintendent cannot have conversations with those individuals involved.

Stacey Smith

Ms. Smith is the mother of the three-year-old from School #4. Her response to Ms. Glaud was that the teacher was never removed from the building. She stated that there were three incidences with her son and she was never given an incident report by the school Principal. Her son has a special diet and his food should have never been taken away from him. She wants the School Board to understand her pain when DYFS showed up at her house. Ms. Smith asked what the procedure is to discipline a teacher who is not tenured and who has multiple allegations against them in the last seven weeks. Ms. Pitts invited Ms. Smith to meet with the Board in confidence to discuss. Ms. Pitts also asked Ms. Smith if she was contacted by the Institutional Abuse Investigation Unit with the results of their investigation. The results were not acceptable to her because they only investigated one incident. Ms. Smith also wants to know why she hasn't seen the video footage from the incident involving her son. Ms. Pitts once again invited Ms. Smith to the Executive Session. Dr. Poteat addressed Ms. Smith's request to see the video footage by email.

Shamar Adams

Mr. Adams is the father of three-year-old from School #4. He has been dealing with this for a month and a half and there is no reason to go back and forth with who should be teaching their child. Mr. Adams told the Board to not wait for something else to happen.

Mr. Kanu is a parent of one of the children in the classroom. He said that the kids are afraid to go back to the classroom. That's a sign that something is wrong. Mr. Kanu stated that this is a grant funded program and he speaks for all the parents whose kids are in the classroom. Until the teacher is removed, their kids won't return to the classroom.

Dina Holmes

Ms. Holmes has been teaching for twenty-two years. She treats children as if they are her own children and she is outraged by the way the teacher is treating the students in the Pre-K class. She stated that the emails that were sent out were very vague and is disturbed by the lack of urgency and transparency regarding the situation. Ms. Holmes wanted to know why a highly qualified veteran teacher with no complaints had been transferred. She will not send her child back to a classroom with a teacher she is afraid of.

Eric Holmes

Mr. Holmes's daughter attends the same class. He's looking for results and if the situation isn't resolved, the Board will hear his roar.

Jovanni Polhill

Ms. Polhill apologized to Ms. Smith for what happened to her child. Ms. Polhill has three boys who attend schools in Winslow Township and has noticed a pattern within the District. There are several teachers who are bad apples and she has had several incidences with all three of her sons pertaining to mistreatment from the teachers. She stated that there are so many system failures in Winslow Township and she is embarrassed that Winslow Township is where she graduated from.

WHEREAS, the nine (9) exceptions to public meetings set forth in N.J.S.A. 10:4-12(b) are listed below, and the items to be privately discussed that fall within such exceptions shall be identified and written, and after each exception is a space where additional information that will disclose as much information about the discussion as possible without undermining the purpose of the exception as follows:



"(1) Any matter which, by express provision of Federal law, State statute or rule of court shall be rendered confidential or excluded from public discussion." The legal citation to the provision(s) at issue is: relative to student matters and the nature of the matter, described as specifically as possible without undermining the need for confidentiality is student matters;



"(2) Any matter in which the release of information would impair a right to receive funds from the federal government." The nature of the matter, described as specifically as possible without undermining the need for confidentiality is ______;



"(3) Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly." The nature of the matter, described as specifically as possible without undermining the need for confidentiality is

"(4) Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body" The collective bargaining contract(s) discussed are between the public body and ;

"(5) Any matter involving the purchase lease or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed." The nature of the matter, described as specifically as possible without undermining the need for confidentiality is _____;



"(6) Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection. Any investigations of violations or possible violations of the law." The nature of the matter, described as specifically as possible without undermining the need for confidentiality is_____;

"(7) Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer." The parties to and docket numbers of each item of litigation and/or the parties to each contract discussed are ______
