PERFORMANCE RESPONSIBILITIES:

- 1. Conduct a daily safety inspection of the bus, complete the School Bus Condition Report and submit weekly.
- 2. Obey all traffic laws.
- 3. Notify the proper authority in case of mechanical failure or lateness.
- 4. Observe all mandatory safety regulations for school buses.
- 5. Maintain discipline when students are on the bus.
- 6. Report undisciplined students to the proper authority.
- 7. Adhere to established routes, designated bus stops and keep to assigned time schedule.
- 8. Discharge students only at authorized stops.
- 9. Keep assigned bus clean and fueled.
- 10. Exercise responsible leadership during school trips.
- 11. Transport only authorized students.
- 12. Report all accidents and complete required reports.
- 13. Enforce regulations against smoking and eating on the bus.
- 14. Attend all department safety meetings and trainings.
- 15. Perform any and all other bus driver duties as may be assigned by the Supervisor.
