Ms. Pitts – The Board has called this Special Meeting for the purpose of addressing concerns voiced by the community at our last meeting on May 28, 2014. Several suggestions and recommendations were put forth by members of the public relating to the newly revised Dress Code Policy. One such recommendation concerns the color of pants, skirts etc. to be worn by our students. The Board and Administration listened and it is my understanding that the Building Principals have reversed their previous decisions.

Therefore, the color of pants, skirts, etc. worn by all students will be **navy blue or khaki pants**. Another issue raised concerns the dress code for physical education in our elementary schools. Page 8 under the Uniform Dress Code for physical education. Students will follow this procedure for physical education days and classes in elementary school:

- Elementary School students will be asked to wear sneakers on their physical education days.
- Sweatpants or gym shorts may be worn on gym days (grey or dark green).

The wording will be changed to "dark green" for shirts in the policy.

Strike out "plain grey" and replace it with "grey" in the policy.

Dr. Poteat – The Administration is in support of the Dress Code Policy and we are looking forward to a smooth transition into this policy in September. We are hoping that the parents in the community, after today, are receptive to where we are and that we continue to educate our young people and it does not become an issue for us on a day to day basis.

# Michelle Johnson - Parent

Just want to clarify that the uniforms can now be khaki, navy pants, skirts or shorts and the shirts can be dark green, white and grey for boys and girls elementary through high school. Also the acceptable form of income should be "and" not "or" because you will have people coming to you with eight paystubs or this, or this.

# Gwendolyn Bowman – Parent

I just want to piggy back on what Michelle just said in regards to the forms of income. When you talk about saying it can be a tax return or a W2 I think you are setting yourself up in the sense that I might work and only make \$250/month but you are not seeing the full tax return where my husband is also making \$70,000/year. I think it is important to ask for that instead of asking for just one or the other so that we are not taken advantage of. There are a lot of things in this District that still need to happen on top of this \$100,000 we are spending to subsidize people for their uniforms. That is my opinion. I hope I don't get tomatoed on my way out. I have to ask about shoes because you tell a child you have to be in a polo, pants etc. but you can wear whatever shoes you want. Because looking today when we had field day, they all looked great. I am looking at them with polos, khakis and sneakers that are all different colors and twenty five different colored socks. I think it looks ridiculous. I feel if you are in a uniform it should be head to toe. I am not saying go out and get green shoes or chestnut brown, I am saying a basic black sneaker, a basic white sneaker, a basic brown sneaker, something along those lines.

Ms. Pitts - The policy remains the same. It does not say you have to wear a polo shirt.

If I worked for a company for two years and I presented something like this I would be reprimanded or fired and just because you are a Board ....doesn't mean you have the right to....

- Are dresses an option for uniforms?
- Do they wear their polo shirt or their blouse for gym or will they give us a grey tee shirt like the middle or high school?
- Ms. Pitts The gym clothes, according to the policy, they will wear the regular clothes with sneakers.
- They can wear tee shirts on gym day.
- The colors for the jumpers are khaki and navy.
- Cardigans are allowed.
- Dresses are allowed.
- Jackets can be worn during the day in the appropriate is acceptable.
- Small logo on the clothes is acceptable.
- Regular clothes can be worn on picture day.
- Confidentiality will be maintained with regards to receiving reimbursement.
